## ALERT—ALERT—ALERT!!!

The Natural Heritage Program within the Department of Conservation and Recreation needs your help ASAP! It is in desperate need of an increase in its budget to manage Virginia's beautiful Natural Area Preserve System. As you know better than most citizens, Virginia's natural areas protect some of the Commonwealth's rarest natural communities and rare species habitat. Since 2002, 29 new Natural Area Preserves, and an additional 35,000 acres have been added to the system, but the budget and staff needed to manage these areas has not kept pace. In fact, Natural Heritage's budget has been cut over the previous ten years.

Over the past three months the Virginia Native Plant Society, through several influential members (Suzanne Jenkins, Alan Ford, Nancy Sorrels and Marcia Mabee), successfully persuaded several key Members of the Virginia legislature to introduce House and Senate FY 2015-16 budget amendments to increase Natural Heritage's budget so that 26 new staff can be added and other costs met.
