This year we celebrate 32 years as a chartered organization and we have had a productive and informative year. Our membership continues to grow, we now have over 490 memberships representing about 580 members. These numbers speak to our accomplishments in outreach and communication and reflect a growing interest in native plants as an integral part of our landscape. Our members are also advocating for increased protection and recognition of the critical need for conservation and restoration of our natural areas throughout the region. Your contributions of time, money, and expertise are gratefully acknowledged.

We have three important tasks to accomplish at our upcoming Annual Meeting on October 13th at 12:30 at Green Spring Garden Park. We need to elect our Chapter Officers for the next year, we need to approve a budget, and we need to address some issues with our By-Laws. This governing document was last modified in 1998.

FINANCES

Our Society has approved a change in the Fiscal Year to align with the calendar year starting January 1. All Chapters will follow this change. This is a welcome adjustment. Our Board has implemented a continuing budget for November and December allocating income and expenses proportional to the current budget. We will maintain the same rate for all line items.

Also of importance is the decision by the Society Board to decrease the portion of member dues returned to the Chapter from 40% to 35%. This will impact the Chapter income. We have been successful at increasing our membership this year and feel we should realize the same amount from membership dues during the coming fiscal year.

BY-LAW REVISION

recognized that it is very difficult to get a quorum of members at our Annual Meeting, through which we must conduct the business of the Chapter, and without which we have not met our obligations. After much discussion and debate we approved the following amendment to the By-laws to ensure we have a quorum. Please review and vote, either in person at the meeting or by the included ballot. Without a quorum we cannot change the by-laws.

BYLAWS 10/1998 (Proposed revision to be submitted for membership approval at the 2013 annual meeting)

4. Meetings

- 4.4 Fifteen percent (15%) of the members (including proxy votes, either written or implicit—see paragraph 4.6) shall constitute a quorum. If a quorum is present, a majority vote shall prevail.
- 4.6 A member may vote in absentia by giving the Secretary, in advance of the meeting, a written proxy authorizing the Secretary to cast a vote for or against a resolution or for a candidate or slate of candidates as presented in the notice of the meeting. In the absence of a written proxy vote, the member will be assumed to have submitted a proxy vote consenting to the proposed resolution, candidate, or slate of candidates.

8. Expenditures and Contributions

8.2 The fiscal year of the Chapter shall be concurrent with the fiscal year of the Society, November 1 through October 31.


