Annual Picnic Sunday May 16 at the Vining Tract off 33 in Lydia.

The Vining Tract is an 800 acre property adjacent to the SNP and connected to the park by trail. It contains a number of short trails from a half mile to three miles in length that wind through lush woods, meadows and along cliffsides. Because of the varied terrain the modest area has a wide variety of native plants. We have rented a cabin Muttontop for the occasion. The trails connect directly to the doorstep of the cabin. The area around the cabin has some items of historical interest including the “Churchill bathtub.”



Our plan is to arrive around 1pm (folks can arrive later, if need be) and spend an afternoon leisurely exploring the trails which run from the cabin to the national park. At 4:30, we will begin the potluck. There is no fridge so bring food that won't spoil. Water is available at the hand pump. There is a big veranda with a great view to the east, which offers shelter from sun or rain. Please come and stay a while.

Directions: Take 33 East past Swift Run Gap. As you descend on the east side of Swift Run Gap take SR636, the first road on your right about a half mile

past the park boundary, and just past Blue Ridge Pottery. Drive about one mile on 636 until you come to the parking lot. It's a rough road but doable in a Honda Civic.

are under increasing pressure for specific uses, especially now because of the potential energy resources they contain. Native Grass Seedling Project for SNP

Last year, you helped us triple the number of native seedlings that Shenandoah produced for restoration projects. Thanks to you, we established over 6000 native grass plants at restoration sites in the Park! Sites that were once covered with mile-a-minute and Japanese knotweed are slowly but surely being converted to locally-native grasses.

This year, I'm hoping we can top this number. But I only have so much windowsill space. So, if you've got an unadorned window that could use an attractive salad container or two of potting soil beneath it for 6 weeks or so, let me know and I'll hook you up. As last year, we're working primarily with little bluestem, Indiangrass, hairgrass and poverty oat/moonshine grass. If you're interested let me know how many containers you can accommodate.

We can also use help with transplanting seedlings and, later in the summer, collecting seed. Again, let me know if you're interested and I'll put you on the list.
