Friday, May 20, 5:30-dark. <u>Grand Caverns Regional Park</u> has received some much needed TLC over the past few years and will be a good place for our annual Picnic. Potluck will start at 6pm in the picnic area. Look for us at one of the shelters.

Directions: On I-81, North or South: Take Exit 235 onto Route 256, travel East on SR 256 for approximately 6 miles [Left if traveling South on I-18, Right if traveling North on I-81] toward Grottoes, VA. At the intersection of Dogwood Avenue, turn right onto Dogwood Ave. Travel south on Dogwood Ave. for 1,000 feet Turn Right into the entrance of Grand Caverns.

On US 340, North or South: At the Grottoes intersection of SR 256, travel West [turn Right if traveling South, turn Left if traveling North] for 1,200 feet. At the intersection of SR 256 and Dogwood Ave. turn Left onto Dogwood Ave. for 1,000 feet. Turn Right into the entrance of Grand Caverns.

After dinner, there will be enough sun-time to explore trails in the area. Good views of the Blue Ridge can be had from the trail behind the visitor center. The trail along the South River is an easy walk and usually has some interesting wildflowers.

Please bring a dish to share. The Chapter will provide paper plates and utensils. In the past, we have provided beverages which we will NOT be doing this year, so please bring your own drinks.
